<p><b><u>Change to isolation period for close contacts.</u></b></p> <p>On the 11<sup>th</sup> December 2020 the <a href="#">Department for Health &amp; Social Care</a> released the <a href="#">UK Chief Medical Officers' statement</a> regarding the reduction in the number of days people have to self-isolate from <u>14 days</u> to <u>10 days</u>. the change applies from 00:01am on Monday 14 December.</p> <p>The change to the isolation period for close contacts will apply to all those who are currently self-isolating including those who commenced self-isolation before Monday the 14<sup>th</sup> December, their self-isolation can now end after 10 days.</p>

**Self-isolation is essential to reducing the spread of COVID as it breaks the chains of transmission.**

**People who return from countries which are not on the travel corridor list should also self-isolate for 10 days instead of 14 days.**

**People who test positive should continue to self-isolate for 10 days from onset of symptoms or 10 days from point of taking a positive test if asymptomatic.**

**[The Guidance for full opening: schools](#) was updated on the 14<sup>th</sup> December 2020 to reflect the change in the isolation period.**

**Risk Assessment update-All references to 14-day isolation contained within the COVID-19 risk assessment are to be changed to 10-days isolation.**
